



BSSW HOUSE RULES SUPPLEMENT FOR THE S1GP HUNGARY EVENT

1. Entry to the Black Star Speedway Visonta (BSSW) is only permitted during the Operator's official opening hours and in accordance with the General Terms and Conditions (GTC), the GTC Supplement, and the provisions set out in this House Rules Supplement.

Admission is allowed with a valid ticket on paid program days, with a registration ticket on free program days, and without a ticket on all other days.

2. Upon entry, the Operator checks the validity of the voucher associated with a regular admission ticket. In most cases, this voucher is not exchanged for a wristband. The voucher permits single entry only. Therefore, if a visitor leaves the BSSW premises after entering, they must purchase a new admission ticket to re-enter.

Visitors must keep their ticket with them at all times while on the premises. The Operator reserves the right to check the validity of the voucher anywhere on the premises. If the visitor's voucher is found to be invalid, they must leave the BSSW.

For certain programs, if the Operator exchanges the regular ticket for a wristband at the entrance, then the wristband shall be subject to the same rules as wristbands issued for VIP admission. VIP tickets are exchanged for wristbands at the entrance. These wristbands permit multiple entries during their validity period.

Visitors must wear their wristband for the entire validity period, including during entry, re-entry, and while inside the BSSW.



If a visitor's wristband is invalid, they must leave the premises. The wristband is non-transferable.

Wristbands worn on the wrist are considered valid, although the Operator may approve the use of a wristband on another body part if it cannot be removed without damage. Damaged (re-glued, cut, broken fastener, excessively loose, tampered with, etc.) wristbands are invalid.

Lost or damaged wristbands will not be replaced or reissued by the Operator. The Operator will initiate proceedings against individuals who counterfeit or assist in the counterfeiting of tickets.

3. Entry to and exit from the BSSW premises is only permitted through entrances monitored by event staff.

The BSSW uses a licensed private security service in accordance with Hungarian Act CXXXIII of 2005 on the Rules of Personal and Property Protection and Private Investigation (referred to as the "Security Act").

Before entry and throughout the event, staff or security personnel may inspect visitors' clothing and bags in accordance with Section 26 of the Security Act. Security staff may deny entry or remove individuals carrying prohibited items.

Security personnel are authorized to deny entry or remove persons who violate the GTC, its Supplement, or this House Rules Supplement—especially if the person fails to comply even after being warned.

Entry to the BSSW may also be denied if the individual:

- (i) Disobeys the instructions of the Operator or its representatives (e.g. security staff),



- (ii) Refuses the necessary security screening,
- (iii) Wears inappropriate, soiled clothing or fails to meet basic hygiene standards,
- (iv) Cannot prove their age with a valid ID or equivalent documentation,
- (v) Has previously been banned from the BSSW.

Entry will be denied without refund in these cases.

In the event of an epidemic or pandemic, entry to the BSSW may be subject to additional procedures and requirements based on applicable legislation, regulations or directives issued by the authorities, and the Operator's own Epidemic Safety Plan.

The Operator may deny entry to any individual whose condition threatens the safe and orderly conduct of the event or poses a danger to other visitors or property.

Entry may also be denied to any person showing symptoms of an illness that forms the basis of an epidemic/pandemic. The Operator assumes no liability in such cases.

No refunds will be issued to individuals denied entry or removed from the event due to the above reasons.

4. The Operator reserves the right to restrict the types of items and equipment allowed into the BSSW. The following are strictly prohibited:

- Narcotics,
- Pyrotechnic devices,
- Glass objects,
- Umbrellas,
- Explosive, toxic, or flammable substances,
- Firearms, knives, butterfly knives, switchblades, gas sprays, batons, telescopic batons,
- Metal chains over 50 cm in length,
- Throwing stars, slingshots,



- Any item considered particularly dangerous to public safety as per Hungarian law (currently 175/2003. (X.28.) Government Decree),
- Balloons, inflatable items, lanterns.

Drones may only be brought into the BSSW with prior written authorization from the Operator.

Flying drones over the BSSW premises from outside is also strictly prohibited. In such cases, the Operator will notify the appropriate authorities.

5. Visitors are not permitted to bring drinks (alcoholic or non-alcoholic) into the BSSW, except bottled (mineral) water under the conditions below:

In case of a heat alert issued by the public health authority (ÁNTSZ), a reasonable quantity of water for personal use is allowed.

Otherwise, visitors may bring only one bottle of water (maximum 0.5 liters, PET only).

Empty plastic water containers may be brought in.

Food may not be brought in commercial quantities. Any quantity exceeding reasonable personal use is considered commercial.

6. Only travel bags, sports bags, laptop bags, backpacks, or plastic bags smaller than 40×30×20 cm may be brought into the BSSW.

Larger bags or umbrellas are not permitted, and individuals may not even present them for security inspection.

7. Children under 14 years of age may only enter the BSSW and remain on the premises if accompanied by a legal adult guardian.

Each adult may accompany a maximum of two children.

- Children aged 0–7 years (not yet 7 on the day of entry) may receive a free child wristband at the entrance. The guardian must write the child's name and their own phone number on the wristband.



- Children aged 7–14 years (up to but not including the 14th birthday on the day of entry) must have a child ticket.

8. Only assistance dogs as defined by law (guide dogs for the blind, service dogs, and police dogs) are permitted entry to the BSSW.

Entry requirements for such dogs include:

- Valid vaccination certificate including rabies vaccination less than one year old,
- Unique identification (readable tattoo or microchip),
- Leash, collar, and a tag with the owner's phone number.

These conditions may be checked at the entrance, and failure to meet them means the dog will not be allowed in.

The visitor accepts full responsibility for maintaining proper hygiene and welfare conditions for the dog while on the premises.

The Operator reserves the right to deny entry on a case-by-case basis or to remove a dog if the above requirements are not met.

Recommendations:

- Muzzles are not mandatory but are recommended,
- If the dog is overly sensitive to audio-visual stimuli or reacts differently from its training, the use of a soft muzzle is suggested.

Entry with a service dog is the sole responsibility of the visitor.

If the dog behaves inappropriately compared to its training, it may be removed from the premises.
